# Ban of mineral oils in printed products intended for the French market

In 2020, France published Decree No. 2020-105 on the 'Fight Against Waste and the Circular Economy'.<sup>1</sup> Article 112 to this law regulates the use of mineral oils on packaging and free advertising. The article prohibits mineral oil containing substances that interfere with waste recycling.

The decree with criteria for printing ink was issued in January and subsequently amended in May 2022.<sup>2</sup> following comments during the TRIS notification period. The result is a longer implementation time than initially proposed and clarification on definitions.

The requirements apply to all packaging and unsolicited flyers and catalogue letters from January 1<sup>st</sup>, 2023, and then for all printed products after January 1<sup>st</sup> 2025 intended for the French market.

If any of the limits are reached, the inks are not compliant and must not be used.

The compliance status of our ink series are as follows:

### HEATSET

**SunFashion BE** and **SunOne BE** inks are compliant to the limits which will apply from January 1<sup>st</sup> 2023.

The inks are not compliant to the limits which will apply from January 1<sup>st</sup> 2025. Until then significant changes in raw material sourcing and production processes will be needed to meet the criteria.

## COLDSET

Newspapers and books are not in the scope of the law until January 1<sup>st</sup> 2025. If products within the scope of the law are coldset printed, then only mineral oil free **SunNews V** inks can be used. The formulations of **SunNews V** inks are already compliant to the limit which will apply from January 1<sup>st</sup> 2025.

## **COLDSET Waterless**

Newspapers and books are not in the scope of the law until January 1<sup>st</sup> 2025. **SunNews AF WP** inks are already compliant to the limits which will apply from January 1<sup>st</sup> 2023. Therefore, products within the scope of the law can be printed with this ink set.

The inks are not compliant to the limits which will apply from January 1<sup>st</sup> 2025. Until then significant changes in raw material sourcing and production processes will be needed to meet the criteria.

## PUBLICATION GRAVURE

The French authorities consider toluene as a MOAH with one ring, because it is derived from petroleum feedstocks. Therefore, inks containing more than 1% of toluene are not compliant to the criteria which will apply from January 1<sup>st</sup> 2023.

Lab evaluations on alternative solvents and discussions with the French authorities about potential derogations due to the low toluene content in the final product and the toluene recycling process are ongoing.
